

Saint Patrick's Pot of Gold – Terms & Conditions

(Scrabo Golf Club)

1. Promoter

This competition is organised and promoted by **Scrabo Golf Club, 233 Scrabo Road, Newtownards, Co. Down, BT23 4SL.**

2. Eligibility

- Open exclusively to **current Club Members** and their **invited guests**, aged **18 or over**.
- Proof of age may be required.
- Committee members involved in running the Promotion may participate.
- Members and Guests may enter while visiting the Club or online and must provide accurate contact information.

3. Promotion Period

- Ticket sales run from **01/02/2026** until **14th March 2026 @ 12 noon**.
- **Weekly Draws:** Held on Sundays each week during the Promotion Period.
- **Grand Draw:** All valid entries, including entries that have already won weekly prizes, will be included in the Grand Draw on **14 March 2026**.

4. How to Enter

- Tickets cost **£2 each**.
- Tickets may be purchased at the Club bar/reception or via our website.
- Each ticket equals **one entry** into the next weekly draw **and** the Grand Draw.
- Tickets are non-refundable unless required by law.

5. Prizes

Weekly Prizes

- Weekly prizes will consist of **spirits, beer and 4ball vouchers** as advertised each week.

Grand Draw – Pot of Gold

- A share of the “Pot of Gold” will be awarded to the winner in the Grand Draw.
- Total prize pot and prize split will be announced prior to the Grand Draw (e.g., 50% of pot - 1st Prize, 50% funding towards Club projects and machinery).
- Prizes are non-transferable.
- If a prize becomes unavailable, the Club may substitute it with a prize of equal or higher value.

6. Draw Process

- All draws will be conducted fairly and at random by a **Club Official / Committee Member**, witnessed by at least one additional member of the Committee.
- Weekly draws include all tickets purchased since the previous weekly draw.
- All valid entries, including weekly winners, will automatically be included in the Grand Draw.

7. Winner Notification

- Winners will be announced **in the Clubhouse**, and where appropriate, notified via **[phone/email]** using the contact details provided at purchase.
- If a winner cannot be reached or does not claim their prize within **14 days**, the Club reserves the right to redraw or reallocate the prize.

8. Publicity

- Winners may be asked for a photograph or to have their name displayed on Club noticeboards or social media.
- If you prefer not to appear in publicity, please inform the Club at the time of the draw.

9. Data Protection

- The Club will only collect personal information needed to administer the competition.
- Information will not be shared outside the Club except where required for prize fulfilment or legal compliance.
- All personal data will be handled in accordance with applicable data protection laws.

10. Fairness and Disqualification

- The Club may refuse or void any entry that is incomplete, illegible, fraudulent, or otherwise not in accordance with these Terms.
- The Club may amend, suspend, or cancel the competition if circumstances outside its control make it necessary (e.g., closure of the Club, technical issues, or safety considerations).

- The Club accepts no responsibility for lost entries, technical issues, or failure of entrants to receive notification.
- Nothing in these Terms limits the Club's liability for fraud or personal injury resulting from negligence.

12. Governing Law

- These Terms and the competition are governed by the laws of **Northern Ireland**, and any disputes will be resolved under NI jurisdiction.
